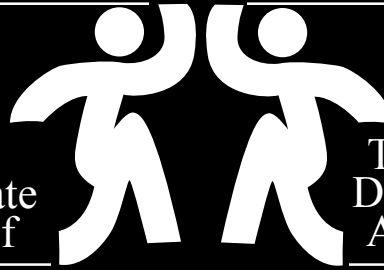

CREATIVE ARTS THERAPIES WEEK JUNE 1st-7th 2003

This is a preliminary communication to begin our thinking about CAT Week. As a Creative Arts Therapist, we hope that you will take the opportunity to share in spreading the word about the power and the effectiveness of the healing arts during the first week of June. This year, NCCATA wants to involve as many of its members as possible in the celebration of CAT week, and to use the week as a real public relations effort for our disciplines throughout the United States. Progress in legislative efforts and professional recognition depend on positive visibility. In support of this initiative, we offer the following suggestions and urge you to collaborate with your colleagues in the development of these and other projects and events.

1. Host an open house with other CAT colleagues to display and demonstrate your modality or provide a workshop or seminar open to the public.

2. Offer to run a career day with colleagues at a local high school or college.
3. Provide a staff development in-service to broaden the knowledge of other professionals in your own institution or agency.
4. Visit other schools, nursing homes, day care centers to provide a creative arts therapy experience.
5. Arrange a display at your local library (and in your own institution or agency!)
6. Put up posters and leave flyers where ever you go. (Flyers will be available from NCCATA).
7. Media Coverage. Send out a press release to your local paper announcing Creative

Arts Therapies Week activities in your community. Send a letter or e-mail to the Public Service Director of your local radio and TV stations for a PUBLIC SERVICE ANNOUNCEMENT. (Be sure to include your contact information.) Arrange for you or a colleague to be INTERVIEWED by a local paper or station, highlighting your work.

Therapy. Social therapy, in practice, could be described as a verbal form of the Marian Chase Method of Dance Therapy. It is highly improvisational, and emphasizes the activity of the group, rather than the content of the conversation. That is, group members are concerned with creating something together – building with each other's offerings, and per-

forming a line in a play. Social therapy challenges all of our assumptions about who we are. For those of you who are familiar with Vygotsky, it is concerned with zones of proximal development – helping people to become what they are not. For those who are familiar with Wittgenstein, it takes from him the idea that we create meaning at every moment;

meaning is particular to each context. Social therapy also takes from Marx the idea that human beings are primarily social and historical. That is, we are in history, and therefore continuously changing. We don't have to find out who or what we are, because we are always becoming, and simply don't know, can't know, who we are.

As the fund raising chair, I will be working with the board to develop fundraising activities for the chapter. My first question to the board, and to the membership is, "What are we raising money for?" Without a compelling mission, how do we persuade people to work at fund raising or to give to our cause? Fundraising organizations, such as Rotary, or the Cancer Society, raise money for charitable causes, or to enrich their own charitable programs. Professional organizations, such as the American Psychological Association, which we are most like, raise money to help pay for the operation of their services to the membership. We, the NYS Chapter board, have very low operating costs (no rent, no salaries to pay), which are currently covered by dues. It seems to me, that to justify fund raising, we have to go beyond what we currently are doing. We have to want more from the board. What would you like from the board that we currently can't afford, but with fund raising, might be able to afford? What professional activities would you like to engage in that as an individual you can't, but as a group, we can? Seven DMTs attended a chapter meeting which I facilitated, after the one-day CAT Conference organized by Anne Marie Truppi and sponsored by the Consultation Center in Albany on March 14th. The meeting involved sharing recent successes and venting frustrations about: the national ADTA, difficulties getting jobs, being underpaid and feeling isolated upstate.

Dance/Movement Therapy with Adolescents in an inpatient locked psychiatric unit

When I was in the process of moving to Albany in 1998, I made contact with hospital administrators all around the Capital District to see if they were familiar with Dance/Movement Therapists or Creative Arts Therapists. Fortunately, Ellis Hospital in Schenectady, NY had an Art Therapist and was very interested in hiring a Dance/Movement Therapist to work with both their adult unit and their brand new adolescent inpatient unit. We were able to contract for my work on a per diem basis (they did not have a full time job available), and my time with both the inpatient units and the Continuing Day Treatment Center has increased over the years.

It is now four and a half years that I have been working at Ellis, and I wanted to share some of my experiences in working with the adolescents. First of all, I love this age group. They are dynamic, full of energy, often very creative, and most especially, love to have an opportunity to use their bodies in a fun, creative way.

Many of the young people who come to

the Adolescent Treatment Center at Ellis have trauma backgrounds including physical and sexual abuse, and incest. Many of them have experimented with drugs and alcohol, and many of them engage in self-mutilation.

I presently work 2 days a week at the unit. Since patients come into the hospital initially for very short term treatment, there is usually a fast turnover in population. When I come into work, I have no idea who will be there and what I will be dealing with. Sometimes the unit is "quiet", which means there have been no violent incidents, "codes", or restraints. Other times, I am coming in after there have been incidents.

The unit has 16 beds. I work in a small room in which I need to clear the tables and chairs in order to work. I take 8 patients in the group for 45 minutes at a time. I often have little control over who will be in my group (in terms of diagnoses), but I do insist that who comes, can handle physical activity and is not actively experiencing "psychosis".

I come with several bags on wheels including my CD player, props bag, and lots of CD's with a wide range of music including:

Rock, pop, R&B, rap, heavy metal, classical, oldies, alternative... and others.

I have a wide range of warm-ups, dance and movement exercises and group activities and interactive games using props that are in my "bag of tricks". I use much of the Chacian format and principles to help the group get to know each other and begin to communicate non-verbally. If there are young people who have never been on the unit and a majority of the patients don't know each other, I use movement "get to know you games" as a light introduction. I make it clear that I expect every one to do their best, but that no one is forced to do what they are not comfortable with. Recently, I got a donation of very pretty colored rug samples, and every one in the group gets to choose one to sit on when : they are tired, if they feel they need to regroup, or have a home base, or when I feel the group is getting out of control. We also begin the group with "ground rules" re: "safety, respect for each other, and choices around personal space and touch". Since sometimes

HILL DAY

Hello all! The ADTA is sponsoring a Hill Day in Washington, DC on April 4, 2003. We feel it is important to send a message of inclusion of Art Therapy, Dance Therapy, and Music Therapy in the IDEA (Individuals with Disabilities Education Act) revisions bill. Specifically, we are asking our Senators and Representatives to add "Art, Dance, and Music Therapy" under the "Related Services" Definitions Section 1401 (22). This will allow more access for Creative Art Therapy services to special education students and more job opportunities in schools for Art Therapists, Music Therapists, and Dance/Movement Therapists.

Please help support our efforts by faxing (not mailing) the following sample letter to your respective legislators:

Dear Senator or Representative _____:

I am writing to request your support of IDEA Reauthorization legislative language recommendations submitted to the Senate Committee on Health, Education, Labor and Pensions and the House Committee on Education and the Workforce by the American Dance Therapy Association. Specifically, I would like for you to support inclusion of the term "art, dance, and music therapy" in the Definitions of Related Services, Sec.1401 (22) - and in the Definitions of Early Intervention Services, Sec.1432 (4) (F).

Art, Dance, and Music Therapy are recognized related services. However, school districts sometimes refuse to provide these services when they are appropriate and necessary, using their rationale that art, dance, and music are not currently among the listed services in the IDEA. Adding art, dance, and music therapy under related services will ensure that these services are provided when determined necessary by the IFSP or IEP team. Art, Dance, and Music Therapy are also used effectively in the Part C program, encouraging socialization, self-expression, communication, and motor development among infants and toddlers. Listing art, dance, and music therapists as "qualified personnel" will ensure these services are accessible to special education students and are implemented by appropriately trained professionals.

(Optional: My personal experience as a Dance/Movement Therapist/client/parent/administrator has demonstrated that Dance/Movement Therapy has ...please include one to two sentences of an example describing the effectiveness of DMT with students meeting therapeutic goals.)

Thank you for your attention to this important issue for children with disabilities who rely upon us to serve as their advocates.

Dance/Movement Therapy does involve touch, (such as holding hands or movement games, that involve touch), I make sure the kids know they have the choice to "take space" and "use their words" to communicate if they feel uncomfortable. Once all the grounds rules are reviewed, everyone gets to choose one piece of music they would like to hear for the session.

We generally start with a movement "check-in" re: feelings, and then go into a warm-up. I then ask each person in the group to lead some movement or exercise for the warm-up, with the group following them. Not everyone is comfortable with this, but they always have the option to "pass", or do a small movement



(peripheral). We then proceed to many different options including: work with props such as balls, hacky-sacks, a stretch cloth, scarves; structured improvisations involving mirroring, stop and go, shaping exercises. Of course my decisions about where to go with the group are shaped by my observations of how each individual is doing and how the group is doing with each other. We try to end with some verbal processing and a closing movement.

At times, the "process" parts of the group can look very disorganized with small groups of two and three doing different movement interactions at other times, the whole group is dancing and working together, using rhythmic synchrony. Other times there is more symbolic association.

Every session is an adventure. It is so clear that on a locked unit, where there is very little space for kids to work out physically, this

group is invaluable. Dance/Movement Therapy gives them the opportunity to explore healthy physical expression, safe boundaries, interactions with peers using their bodies in respectful ways, and non-verbal expression of feelings. While there is sometimes normal adolescent resistance, when it is clear that they are welcomed without pressure, most of the young people come around to joining in the group at their own pace.

I am grateful to have the opportunity to work with this population, and to be constantly reminded to "be on my toes", be flexible, have fun, and have deep compassion.

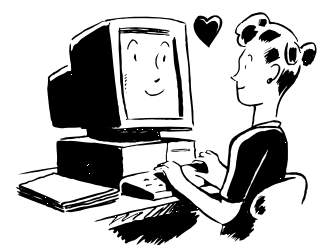
Newsletter
